Q. What is financial aid?

A. Financial Aid is any kind of money that is either given or loaned to you for a period of time that can assist you in paying for school. Last year, Ohio Christian University students received over 4 million dollars in financial assistance.

Q. What is FAFSA?

A. FAFSA stands for *Free Application for Federal Student Aid*. Specifically, the FAFSA is a government document created by the U.S. Department of Education that assists the University in determining how much aid each student is eligible for.

Q. What do I need to complete my FAFSA?

A. We recommend families use the IRS Data Retrieval Tool to import tax information from the IRS to the FAFSA. Using the tool will reduce the time it takes to finalize a financial aid package. If you or your parents have not yet filed your taxes, then you will need to be prepared to enter information from all W2's received for the prior year.

Q. What if I have more questions?

A. The Ohio Christian University Financial Aid Office is more than happy to help you navigate the sometimes confusing world of financial aid.

Presidential Scholarship

The Presidential Scholarship is \$8,000 per year and is awarded to students with a 28 ACT or higher or a 3.75-4.0 college GPA. Students must maintain a 3.75 GPA for the Presidential Scholarship to be renewed each year.

Provost's Scholarship

The Provost's Scholarship is \$5,000 per year and is awarded to students with a 3.75-4.0 cumulative high school GPA or a 3.5-3.74 college GPA. Students must maintain a 3.5 GPA for the Provost's Scholarship to be renewed each year.

Merit Scholarship

The Merit Scholarship is \$3,000 per year and is awarded to students with a 3.5-3.75 cumulative high school GPA or a 3.25-3.49 college GPA. Students must maintain a 3.25 GPA for the Merit Scholarship to be renewed each year.

Academic Achievement Scholarships

Students who have a 3.25-3.5 cumulative high school GPA or a 3.0-3.24 college GPA, are awarded a minimum of \$2,000 per year. Students who have a 3.0-3.49 cumulative high school GPA or a 2.75-2.99 college GPA, are awarded \$1,000 per year. GPA requirement to maintain Academic Achievement is 3.0.

OCU Service Scholarships

The OCU Service Scholarship is up to \$3000 per year and is awarded to students who demonstrate exceptional leadership and service.

Early Admit Scholarships

The Early Admit Scholarship is \$2,000 per year and is awarded to continuing Trailblazer Academy students with an acceptable ACT/SAT/CLT score and who have completed 6 or more dual enrollment credit hours with a 3.0+ GPA.

Pell Grant

The Pell Grant is a federal grant provided to every part-time or full-time student who shows exceptional financial need. The Federal Supplemental Opportunity Grant (FSEOG) is intended to supplement the Pell Grant. It is provided by the federal government to eligible full-time students based on need.

Ohio College Opportunity Grant

The Ohio College Opportunity Grant is a need based grant for some Pell Grant recipients who are Ohio residents.

Church Matching Grant

OCU will match any money that a student's church contributes to his or her education up to \$500 per semester. The Church Matching Grant form is available online at ohiochristian.edu/scholarships under "Church Matching Grant."

Good Neighbor Quality Student Grant

The Good Neighbor Quality Student Grant is a minimum of \$500 per year and is awarded to students who have graduated from a high school in one of the following counties: Pickaway, Ross, Fairfield, Fayette, Pike, Hocking, Madison Franklin or Licking. Students who attend and graduate from a Christian school or Homeschool are also eligible.

Trailblazer Ministry Award

The Trailblazer Ministry Award is a minimum of \$500 per year and is awarded to students who are Church of Christ in Christian Union church members, a missionary child or a pastor's child. Documentation required.

SCHOLARS DAY

Ohio Christian University Scholars Day is an annual event for our highest achieving applicants to compete for the Commitment to Excellence Full-Tuition Scholarship through two separate interviews.

Scholars Day Competition Criteria

- 25 ACT/1210 SAT or higher
- 3.5 GPA or higher and a 3.5 college GPA must be maintained to keep the scholarship
- Accepted applicant to OCU's Campus Undergraduate program
- 2 letters of recommendation — 1 academic and 1 personal
- 1,500 word essay in response to a prompt

Ohio Christian University offers several loan options to help meet the remaining cost of your education — those loan options are:

Federal Direct Loan

The Subsidized Federal Direct Loan is available to students who show financial need, are enrolled at least half-time, and are pursuing a degree. Subsidized loans are awarded in limited amounts, which correspond with a student's year in school. The interest on a Subsidized Federal Direct Loan is paid by the federal government while a student is attending school at least half-time.

The Unsubsidized Federal Direct Loan is available to students who are enrolled at least half-time. There is no financial need taken into account for this loan; students of all income levels may take out the loan. The Unsubsidized Federal Direct Loan has yearly loan limits that correspond with a student's year in school. The interest on an Unsubsidized Federal Direct Loan will accumulate while a student is attending school.

Parent PLUS Loan

The Parent PLUS loan is available to all creditworthy parents of dependent students. Students must be enrolled at least half-time to qualify for the PLUS loan. Interest accumulates while a student is attending school.

Private Loan

Private student loans are credit-based loans that can be used to cover the cost of a student's education after grants, scholarships, and federal loan funds have been exhausted. Students will likely be required to apply with a creditworthy cosigner. The Private Loan has a \$1000 minimum loan requirement and interest accumulates while a student is attending school.

■ Step 1

Apply for admission to Ohio Christian University.

You must be accepted for admission before any aid can be disbursed to your student account. Apply for admission online at **ohiochristian.edu/apply** or call, toll free **(877) 762-8669**.

■ Step 2

Submit the Free Application for Federal Student Aid (FAFSA).

Submit the FAFSA as soon as possible after October 1. You can complete the FAFSA online at **studentaid.gov**. Make sure to use Ohio Christian University's FAFSA school code **003030**.

■ Step 3

Submit necessary documents.

If requested, submit any other paperwork or documents to the Financial Aid Office.

■ Step 4

Apply for scholarships and checkout OCU institutional aid.

A great search engine for scholarships is **fastweb.com**. For more general financial aid information check out **studentaid.gov**. Don't forget to search for scholarships in your community, and inquire about OCU scholarships such as the Church Matching Grant, Good Neighbor Award, Sibling Discount and Academic Scholarships!

Step 5

Sign and return your OCU award letter.

Once we have received all your information, we will send you a billing estimate, including the awards offered to you and instructions on how to pay for school. Signing and returning your award letter will ensure that you get your money in a timely manner.

Step 6

Sign Loan Agreement and complete Entrance Counseling.

Please visit **studentaid.gov** to sign your Loan Agreement and complete Entrance Counseling if you plan to take out Direct Loans. This last step will guarantee your success in the financial aid process!
